CITY ORDINANCE NO. 04, S. 2021

AN ORDINANCE ADOPTING AN OFFICIAL LOGO FOR THE OFFICE OF THE SANGGUNIANG PANLUNGSOD BAYBAY CITY.

WHEREAS, the Office of the Sangguniang Panlungsod is the legislative body of the city government of Baybay;

WHEREAS, the legislative council has its distinct power to formulate rules, laws and ordinances intended for the welfare of the Baybayanon constituents;

WHEREAS, the official SP Logo shall be recognized as one of the city symbols which embody local ideals and traditions that expresses principles of sovereignty, patriotism, solidarity and manifest local virtues of the people.

WHEREFORE, on motion of Honorable Atty. Jose Rommel A. Peñaranda, and duly seconded by Honorable Mark Michael O. Unlu-cay;

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, this city, in Regular Session assembled on February 4, 2021, as hereby is adopted, to wit:

SECTION 1. Title. This ordinance shall be known as, AN ORDINANCE ADOPTING AN OFFICIAL LOGO FOR THE OFFICE OF THE SANGGUNIANG PANLUNGSOD BAYBAY CITY.

SECTION 2. The LOGO Design.



SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof shall remain valid, in full force and effect.

SECTION 4. REPEALING CLAUSE.


All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


SECTION 5. EFFECTIVITY.


