AN ORDINANCE AMENDING CITY ORDINANCE NO. 006, S. 2013, CHANGING THE NAME, OFFICE OF BUS TERMINAL AND TRAFFIC MANAGEMENT IN THE CITY OF BAYBAY TO CITY **TRAFFIC MANAGNEMENT AND TERMINAL OFFICE**.

On motion of Honorable Ramon Ronald J. Veloso, and duly seconded by Honorable Rodulfo S. Palma, Jr. and Honorable Philip L. Siu;

BE IT ORDAINED by the 5<sup>th</sup> Sangguniang Panlungsod in session assembled on February 18, 2021 at the Session Hall, Legislative Building, this city, an ordinance is hereby adopted, to wit:

**SECTION 1. Title.** This Ordinance shall be known as, AN ORDINANCE AMENDING CITY ORDINANCE NO. 006, S. 2013, CHANGING THE NAME, OFFICE OF BUS TERMINAL AND TRAFFIC MANAGEMENT IN THE CITY OF BAYBAY TO CITY **TRAFFIC MANAGEMENT AND TERMINAL OFFICE**.

**SECTION 2. PROPOSED AMENDMENT.**

SECTION 1. Title and Scope – this ordinance shall be known as the Bus Terminal and Traffic Management Office in the City of Baybay.

To:

**SECTION 1.** Title. This ordinance shall be known as, AN ORDINANCE AMENDING CITY ORDINANCE NO. 006, S. 2013, CHANGING THE NAME, OFFICE OF BUS TERMINAL AND TRAFFIC MANAGEMENT IN THE CITY OF BAYBAY TO **CITY TRAFFIC MANAGNEMENT AND TERMINAL OFFICE**.

**SECTION 3. SEPARABILITY CLAUSE.** If any provision of this Ordinance is held in valid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

**Section 4. REPEALING CLAUSE.** Pertinent provisions of all other laws, ordinances, executive orders and rules and regulations contrary to or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.


**Section 5. EFFECTIVITY.**
