CITY ORDINANCE NO. 30, S. 2020

AN ORDINANCE CREATING THE POSITION OF SUPERVISING ADMINISTRATIVE OFFICER (LICENSING OFFICER IV-SALARY GRADE 22, UNDER THE OFFICE OF THE CITY MAYOR.

WHEREAS, the city officials of Baybay saw the need to improve the strategy in the process of revenue collection;

WHEREAS, the Business Permit and Licensing Office is one of the revenue generating agencies of the city that spearheads in garnering collections for the city treasury;

WHEREAS, the said office presently needs a qualified employee to manage for an effective daily operation to boost the economic status of the city.

WHEREFORE, on motion of Honorable Edgardo R. Ompoy, and duly seconded by Honorable Vicente Victor G. Veloso,

BE IT ORDAINED BE IT ORDAINED by the 5th Sangguniang Panlungsod in session on September 24, 2020 at the Session Hall, Legislative Building, this city, AN ORDINANCE CREATING THE POSITION OF SUPERVISING ADMINISTRATIVE OFFICER (LICENSING OFFICER IV-SALARY GRADE 22, UNDER THE OFFICE OF THE CITY MAYOR, is hereby adopted, to wit:

Section 1. TITLE. This Ordinance shall be known as, "AN ORDINANCE CREATING THE POSITION OF SUPERVISING ADMINISTRATIVE OFFICER (LICENSING OFFICER IV-SALARY GRADE 22, UNDER THE OFFICE OF THE CITY MAYOR".

Section 2. NEW PLANTILLA POSITION. A new position is hereby created into the LGU plantilla by the process of addition, the Supervising Administrative Officer (Licensing Officer IV-Salary Grade 22) under the City Mayor's Office.


Section 3. FUNDING SUPPORT. The newly created position shall be made part and parcel of the Baybay City LGU Plantilla, automatically funded from the Personal Services component of the city budget.

Section 4. SEPARABILITY CLAUSE. If any provision of this Ordinance is held in valid or unconstitutional, the same shall not affect the validity and effectivity of the other provisions hereof.

Section 5. REPEALING CLAUSE. Pertinent provisions of all other laws, ordinances, executive orders and rules and regulations contrary to or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.


Section 6. EFFECTIVITY. This Ordinance shall take effect upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.
