"AN ORDINANCE AMENDING CITY ORDINANCE NO. 11, SERIES OF 2016, CREATING NEW PLANTILLA POSITIONS BY THE PROCESS OF ADDITION, AND TO APPROPRIATE THE FUNDS NEEDED THEREOF"

PREFATORY STATEMENT

WHEREAS, City Ordinance No. 11, series of 2016, created plantilla positions in the City of Baybay;

WHEREAS, in line with the City's effort to improve its organizational structure and staffing pattern, there is a need to open new plantilla positions and amend existing position to conform to the human resources need of the city;

NOW THEREFORE, on motion of Honorable Atty. Jose Rommel A. Peñaranda, and Honorable Dominador K. Murillo, duly seconded by the majority of the council members;

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, this city, in its 41st Regular Session assembled on October 15, 2020, as hereby is adopted, to wit:

SECTION 1. Title. This ordinance shall be known as, AN ORDINANCE AMENDING CITY ORDINANCE NO. 11, SERIES OF 2016, CREATING NEW PLANTILLA POSITIONS BY THE PROCESS OF ADDITION, AND TO APPROPRIATE THE FUNDS NEEDED THEREOF".

SECTION 2. Proposed Amendments. Section 2 of City Ordinance No. 11, series of 2016 is hereby amended as follows:

2. One (1) Security Guard III, SG-8, for the City Mayor's Office
3. One (1) Computer Operator IV, SG-14, for the City Budget Office
4. One (1) Bookbinder III, SG-7, for the City Budget Office

SECTION 3. FUNDING SUPPORT.

The newly created positions are made part and parcel of the Baybay City LGU Plantilla and shall be automatically funded from the personal services component of the city budget.

SECTION 4. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof shall remain valid, in full force and effect.

SECTION 5. REPEALING CLAUSE.


All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY.

This Ordinance shall take effect immediately upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991, until mandated otherwise.


