ORDINANCE NO. 33, SERIES 2020

"AN ORDINANCE CREATING NEW PLANTILLA POSITIONS FOR THE RESPECTIVE OFFICES OF THE CITY GOVERNMENT OF BAYBAY AND TO APPROPRIATE THE FUNDS NEEDED THEREOF"

PREFATORY STATEMENT

WHEREAS, the inevitable progressive growth of Baybay City is tantamount to significant increase of personnel in its various offices;

WHEREAS, a sufficient work force in each office is vital for an effective delivery of basic services;

WHEREAS, the Local Chief Executive, Honorable City Mayor Jose Carlos L. Cari, submitted his request for the creation of new positions to be incorporated in the city government plantilla;

WHEREFORE, on motion of Honorable Jose Rommel A. Peñaranda, and duly seconded by Honorable Vicente Victor G. Veloso,

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, this city, in its 42nd Regular Session assembled on October 22, 2020, as hereby is adopted, to wit:

SECTION 1. Title. This ordinance shall be known as, "AN ORDINANCE CREATING NEW PLANTILLA POSITIONS FOR THE RESPECTIVE OFFICES OF THE CITY GOVERNMENT OF BAYBAY AND TO APPROPRIATE THE FUNDS NEEDED THEREOF."

SECTION 2. NEWLY CREATED POSITIONS. The following positions are hereby created:

- 1. For the City Agriculture's Office:
 - Four (4) items Farm Worker II, SG-4;
 - Eight (8) items Agricultural Technologist, SG-10;
 - Four (4) items Agriculturist II, SG-15;
 - Four (4) items Senior Agriculturist, SG-18.
- 2. For the City Health Office:
 - Eight (8) items Midwife 1, SG-9;
 - Four (4) items Nurse 1, SG-11;
 - Four (4) items Public Health Nurse, SG-16;
 - One (1) item Midwife V, SG-17.
- 3. For the City Engineering Office:
 - Two (2) items Construction and Maintenance Foreman, SG-8:
 - Two (2) items Engineer 1, SG-12;
 - Three (3) items Heavy Equipment Operator II, SG-6.
- 4. For the Local Disaster Risk Reduction Management Office:

- Two (2) items Local Disaster Risk Reduction Officer II, SG-15
- 5. For the City Planning and Development Office:
 - One (1) item Architect 1, SG-12.

SECTION 3. FUNDING SUPPORT.

The newly created positions are made part and parcel of the Baybay City LGU Plantilla and shall be automatically funded from the personal services component of the city budget.

SECTION 4. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof shall remain valid, in full force and effect.

SECTION 5. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 7. EFFECTIVITY.

This Ordinance shall take effect immediately upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
