ORDINANCE NO. 34, SERIES 2020

AN ORDINANCE AMENDING THE TITLE OF CITY ORDINANCE NO 14, SERIES OF 2020, INVOLVING THE AREA OF THE LOT RECLASSIFIED, FROM 128,791 SQUARE METERS TO 132,216 SQUARE METERS.

WHEREAS, City Ordinance No. 14, s. 2020 reclassifies five (5) parcels of lot to Parks and Recreation Zone (PRZ) to be utilized as a Memorial Park;

WHEREAS, in the said ordinance, the figure of the area entered was 128,791 square meters, of which the actual area of the reclassified lot is 132,216 square meters.

WHEREFORE, on motion of Honorable Atty. Jose Rommel A. Peñaranda, and duly seconded by Honorable Mark Michael O. Unlu-cay;

BE IT ORDAINED, by the 5th Sangguniang Panlungsod, this city, in its 42nd Regular Session assembled on October 2, 2020, as hereby is adopted, to wit:

SECTION 1. Title. This ordinance shall be known as, AN ORDINANCE AMENDING THE TITLE OF CITY ORDINANCE NO 14, SERIES OF 2020, INVOLVING THE AREA OF THE LOT RECLASSIFIED, FROM 128,791 SQURE METERS TO 132,216 SQUARE METERS.

SECTION 2. Amendment.

From: AN ORDINANCE RECLASSIFYING FIVE (5) PARCELS OF AGRICULTURAL LANDS ...XXX... CONTAINING AN AREA OF 128,791 SQUARE METERS TO PARKS AND RECREATION ZONE (PRZ) ... MEMORIAL PARKS.

TO: AN ORDINANCE AMENDING THE TITLE OF CITY ORDINANCE NO. 14, SERIES OF 2020, INVOLVING THE AREA OF THE LOT RECLASSIFIED, FROM 128,791 SQURE METERS TO 132,216 SQUARE METERS.

SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof shall remain valid, in full force and effect.

SECTION 4. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY.

This Ordinance shall take effect immediately upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
