ORDINANCE NO. 35, SERIES 2020

AN ORDINANCE AMENDING CITY ORDINANCE NO. 07, S. 2011, INVOLVING THE PROVISIONS OF SECTION III THEREOF.

(Sponsored by Honorable Ramon Ronald J. Veloso)

PREFATORY STATEMENT

WHEREAS, it is imperative to amend City Ordinance No. 07, s. 2011 to address various concerns on the rapidly increasing number of motor vehicles plying in the thoroughfares of Baybay City proper;

WHEREAS, there is a need to regulate and impose order to decongest traffic in selected areas;

WHEREAS, motor vehicle drivers and operators have to be properly guided in terms of traffic management to minimize and possibly avoid any form of vehicular accidents.

WHEREFORE, on motion of Honorable Ramon Ronald J. Veloso and duly seconded by Honorable Philip L. Siu,

BE IT ORDAINED, BY THE 5TH Sangguniang Panlungsod in session on December 3, 2020, at the Session Hall, Legislative Building this city, a traffic ordinance is hereby adopted, to wit:

SECTION 1. Title. This ordinance shall be known as, AN ORDINANCE AMENDING CITY ORDINANCE NO. 07, S. 2011, INVOLVING THE PROVISIONS OF SECTION III THEREOF.

SECTION 2. Proposed Amendments.

SECTION III - One Way Traffic and No Entry Area

- a. One Way Traffic From the corner of Magsaysay Avenue and A. Bonifacio Street up to the corner of Rizal Avenue passing through the corner of Rizal Avenue up to corner of Tres Martires and Magsaysay Avenue, including the boulevard from the corner of Rizal Avenue going through the corner of Magsaysay Avenue and Tres Martires Street from 7:00 a.m. to 10:00 p.m.
- b. NO ENTRY of all vehicles from the corner of Rizal Avenue and the boulevard street up to the corner of the street going to RHU-2 which is considered as children's Park, from 4:30 p.m. to 12:00 midnight.
- c. EXIT ROUTE all the openings fronting the Camotes Sea (boulevard road) shall be the exit route for all vehicles from the Bus Terminal in going to their places of destination.

- d. No Parking of any vehicle except for loading/unloading not exceeding ten (10) minutes from the corner of Magsaysay avenue and A. Bonifacio street up to the corner of Rizal Avenue from 7:00 a.m. to 7:00 p.m.
 - 1. No parking of any vehicle at the left side of Rizal Avenue from the corner of the street fronting Captains Grills Restobar, Botica Cayunda, Dada restaurant, Novo Department Store, Shell gasoline station and all the building thereafter from 7:00 a.m. to 7:00 p.m.
 - 2. Unloading of cargoes will be done from 1:00 p.m. to 3:00 p.m. only in the following areas, from the corner A. Bonifacio St. and Magsaysay Avenue up to corner of A. Bonifacio St. and Rizal Blvd.
 - 3. No Obstruction will be made on the street most especially double parking.
 - 4. No parking from the corner of Rizal Avenue and Tres Martires Street up to the corner of M.L. Quezon and Tres Martires Street for more than 5 minutes.
 - 5. No Parking of vehicle from the corner of Magsaysay Avenue and A. Bonifacio Street to the Chinese School and from the corner of 30 de Deciembre and A. Bonifacio to the corner of Juan Luna st. for more than 5 minutes except the loading/unloading of cargoes in these areas from 1:00 p.m. up to 3:00 p.m.
 - 6. No Parking in front of any vulcanizing Shop for the purpose of changing and exchanging of tires for any jeepney, van, trucks and any heavy equipment that will cause traffic jammed.
 - 7. No Overnight Parking of all vehicles along the boulevard from 6:00 p.m. up to 7:00 a.m.
 - 8. No Parking from the gate of Port Area up to Metro Bank at all times.



SECTION 3. SEPARABILITY CLAUSE.

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof shall remain valid, in full force and effect.

SECTION 4. REPEALING CLAUSE.

All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 5. EFFECTIVITY.

This Ordinance shall take effect immediately upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.



REGULAR SESSION OF THE SANGGUNIANG PANLUNGSOD HELD SESSION HALL, LEGISLATIVE BUILDING, THIS CITY, ON MAY 2, 2011

> City Ordinande No. 07 Series of 2011

(Ordinance introduced by Hon. Leonido 7. Beray, Hon. Alan Fernandez, Leoncio Asilom, Jr. and Hon. Lolito Muñez.)

SECTION I - Title - An ordinance establishing a ONE WAY ROUTE, NO ENTRY, EXIT ONLY, NO PARKING and NO OVERNIGHT PARKING on the identified streets of the City of Barbay in the Poblacion area.

SECTION II - Definition of Terms - The following terms used shall be defined as follows:

a. Driver - shall mean any person who manned any vehicle using or passing through the street.

b. Street - a lane usually provided to any vehicle.

c. Vehicle - shall mean any kind of transportation that carries person or goods that passes through the streets.

d. Street Signs - a signage place at the corner or along the side of the street to identify the kind of prohibition impose by the City Government of Baybay.

e. One Way - means passing through the street of one direction only.

No Exit Only - the allowed passage use in going out of a certain place.

g. No Parking - a space not allowed for parking of any vehicle.

h. No Overnight Parking - a space probbited to any vehicle to park from 6:00 p.m. to 6:00 a.m.

i. Unloading Hour - the time of unloading of cargoes and or goods in a specified business establishments identified in this Ordinance is from 1:00 p.m. to 3:00 p.m. only.

Temporary Parking - the loading and unloading of passengers and cargoes not exceeding ten (10) minutes while the engine still running.

No Entry - is the area prohibited for coming inside a certain place.

SECTION III - One Way Traffic and No Entry Area

- a. One Way Traffic From the corner of Magsaysay Avenue and A. Bonifacio Street up to the corner of Rizal Aven passing through the corner of Rizal Avenue up to corner of Tres Martires and Magsaysay Avenue, including the boulevard from the corner of Rizal Avenue going through the corner of Magsaysay Avenue and Tres Martires Street from 7:00 a.m. to 10:00 p.m..
- b. NO ENTRY of all vehicles from the colner of Rizal Avenue and the boulevard street up to the corner of the street going to RHU-2 which is considered as children's Park, from 4:30 p.m. to 12:00 midnight.

c. EXIT ROUTE all the openings fronting the Camotes Sea (boulevard road) shall be the exit route for all vehicles om the Bus Terminal in going to their places of destination.

d. No Parking of any vehicle except for Idading/unloading not exceeding ten (10) minutes from the corner of Magsaysay avenue and A. Bonifacio street up to the corner of Rizal Avenue from 7:00 a.m. to 7:00 p.m.

1. No parking of any vehicle at the left side of Rizal Avenue from the corner of the street fronting Captains' Grills Restobar, Botica Cayunda, Dada restaurant, Novo Department Store, Shell gasoline station and all the building thereafter from 7:00 a.m. to 7:00 p.m.

2. Unloading of cargoes will be done from 1:00 p.m. to 3:00 p.m. only in the following areas; from the corner A Bonifacio St. and Magsaysay Avenue up to corner of A. Bonifacio St. and Rizal Blvd.

3. No Obstruction will be made on the street most especially double parking.

4. No parking from the corner of Rizal Avenue and Tres Marites Street up to the corner of M.L. Quezon and Tres Martires Street for more than 5 minutes.

5. No Parking of vehicle from the corner of Magsaysay Avenue and A. Bonifacio Street to the Chinese School and from the corner of 30 de Deciembre and A. Bonifacio to the corner of Juan Luna st. for more than 5 minutes except the loading/unloading of cargoes in these area from 1:00 p.m. up to 3:00 p.m.

6. No Parking in front of any vulcanizing Shop for the purpose of changing and exchanging of tires for any eepney, van, trucks and any heavy

equipment that will cause traffic jarn med.

7. No Overnight Parking of all vehicles along the boulevard from 6:00 p.m. up to 7:00 a.m.

8. No Parking from the gate of Port Area up to Metro Bank at all times.

SECTION IV - Penal clause - for violation of any section and sub-section of this ordinance will be fine of:

1st Offense

2nd Offense

3rd and Habitual Offense

unless payment of the penalty be made.

P 400.00 P 500.00 plus recommendation for the cancellation of the driver's license and impounding of the vehicle

P 300.00

SECTION V - Separability Clause - if any portion or section of this ordinance be declared unconstitutional or invalid it will not invalidate to whole ordinance.

SECTION VI - Repealing clause -all existing ordinances, rules and regulation which are inconsistent to this ordinarce are hereby repealed, amended or modified.

SECTION VII - Effectivity - this ordinance shall take effect upon the approval of the Sangguniang Panlalawigan.
