CITY ORDINANCE NO. 13, S-2021

AN ORDINANCE PROVIDING BENEFITS FOR ATHLETES, COACHES, TRAINERS AND PWD (PERSONS WITH DISABILITY) ATHLETES WHO REPRESENTED OR HAVE BROUGHT PRESTIGE AND HONOR TO THE CITY IN ANY REGIONAL, NATIONAL OR INTERNATIONAL COMPETITIONS.

WHEREAS, Article II, Section 17 of the 1987 Philippine Constitution provides that "The State shall give priority to education, science and technology, arts, culture and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development".

WHEREAS, Article XIV, Section 19 (1) of the same fundamental law further provides that "The State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry";

WHEREAS, despite the noble intention of the aforementioned State Policy, there is no adequate law that will provide for any assurance guaranteeing the benefits befitting the country's hardworking athletes which may have indirectly resulted in Philippine's lagging at the bottom of international sports competition;

WHEREAS, the City of Baybay, through the able leadership and foresight of the **Honorable City Mayor Jose Carlos L. Cari**, and represented by the youth athletes of the City who have excelled in various local, regional, national competitions, and in some cases, international sports competition;

WHEREAS, for bringing pride, honor and prestige to the name of the City of Baybay, the Honorable City Mayor deemed it right to provide due rewards and cash incentives in the form of scholarship grants or cash incentives whenever appropriate to these deserving athletes, many of whom belong to the underprivileged sector of the community;

NOW THEREFORE, on motion of Honorable Arturo Elisa O. Astorga, and duly seconded by Honorable Mark Michael O. Unlu-cay,

BE IT ORDAINED, BY THE 5TH Sangguniang Panlungsod, that on April 29, 2021, during its 17th Regular Session at the Session Hall, Legislative Building this city, an ordinance is hereby adopted, to wit:

SECTION 1. TITLE This Ordinance shall be known as “**ATHLETES’ COMPENSATION PROGRAM**”,

SECTION 2. COVERAGE

- 1. Athletes representing the City of Baybay
- 2. Coaches/trainers of athletes representing the City in sports competitions
- 3. PWD Athletes representing the City of Baybay
- 4. Athletes who are residents of the City have brought honor to the City or the country in any regional, national or international competition.

SECTION 3. EXTENT OF COVERAGE

The athletes, coaches/trainers who may be entitled to the incentives granted by this Ordinance shall be those who have landed in the top three places of their perspective events, that is, who have earned a bronze (third place), silver (second place) and gold (champion) medals or who has received recognition for his/her performance.

SECTION 4. SPORTS COMPETITION COVERED

A. National

- 1. Philippine Nationals
- 2. Palarong Pambansa
- 3. Batang Pinoy

B. Local & Regional

- 1. EVRAA (Eastern Visayas Regional Athletic Association) Meet
- 2. SCUAA

C. International

- 1. SEA games
- 2. Olympics

Any other sporting events which the **Baybay Sports Development Office** through the Committee on Sports of the Sangguniang Panlungsod, may choose to join other than those mentioned in letters A and B may be automatically covered by the scope of this Ordinance, subject to the approval of the City Mayor.

SECTION 5. INCENTIVES OF ATHLETES IN NATIONAL COMPETITIONS

**SECTION 7. ALTERNATIVE INCENTIVES OF ATHLETES IN LIEU OF CASH
SUBJECT TO THE DISCRETION OF THE CITY MAYOR**

An athlete who has qualified to receive cash incentives may be given partial/full scholarship grant or educational assistance, the amount of which is to be determined by the City's Executive Department.

SECTION 8. OTHER FORM OF INCENTIVE

All active and covered athletes, coaches and trainers irrespective of whether they win a medal or not should be covered with an accident or death insurance every year any sports competition.

SECTION 9. SOURCE OF FUNDS

The cash incentive as well as the amount for the payment of the premium for accident/death insurance covered by this Ordinance shall be taken from the Mayor's Social Fund. The fund to be used shall be sourced from the General Fund Specifically Social Fund under Mayor's Office while the amount to be paid for the scholarship of athletes shall be charged against Gender and Development (GAD) Fund.

SECTION 10. SEPARABILITY CLAUSE If any provision of this Ordinance is held unconstitutional or invalid, the same shall not affect the validity and effectivity of the other provisions hereof.


SECTION 11. REPEALING CLAUSE Pertinent provisions of all other laws, decrees, executive orders and rules and regulations contrary to or inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 12. EFFECTIVITY CLAUSE This Ordinance shall take effect 15 days upon its approval by the Sangguniang Panlalawigan and after due compliance with all the requirements as provided for under R.A. 7160, otherwise known as the Local Government Code of 1991.




