AN ORDINANCE REGULATING BACKYARD PIGGERY PRACTICES IN THE CITY OF BAYBAY, AMENDING BAYBAY MUNICIPAL ORDINANCE NO. 004, SERIES OF 2004

ARTICLE I

Section 1. This shall be known as "AN ORDINANCE REGULATING BACKYARD PIGGERY PRACTICES IN THE CITY OF BAYBAY, AMENDING BAYBAY MUNICIPAL ORDINANCE NO. 004, SERIES OF 2004."

ARTICLE II PURPOSE

Section 1. It is enshrined in the 1987 Philippine Constitution of the declared policy of the State to protect and promote the right to health of the people and instill a consciousness among them to a balanced and healthy environmental ecology. This principle is further strengthened in Chapter XIX (Nuisances and Offensive Trades and Occupation) of the Code On Sanitation of the Philippines, PD No. 856, December 23, 1975. In pursuance of these proclamations, this Ordinance is enacted for the purpose of regulating the setting up and operation of all backyard piggery projects in the city of Baybay.

ARTICLE III OBJECTIVES

- **Section 1.** To make sure that all backyard piggery projects in the city of Baybay comply with all existing and pertinent laws, rules and regulations as well as applicable local ordinances;
- **Section 2.** To promote the general welfare by protecting the health of the populace by focusing on minimizing nuisances such as foul odor, fly infestation and water pollution:
- **Section 3.** To provide the right balance between enterprise and public health through relevant and suitable regulation.

ARTICLE IV SCOPE AND COVERAGE

Section 1. This Ordinance shall be enforced within the territorial jurisdiction of the city of Baybay.

Section 2. The provisions of this Ordinance shall apply to all existing and new backyard piggery projects as well as on the improvements of existing ones.

ARTICLE V DEFINITION OF TERMS

Section 1. Whenever any of these words or terms is used in any section or provision of this ordinance, it shall have the meaning given in this section.

- a. Animal Waste refers to a material composed of excreta collected from piggeries;
- b. Backyard Piggery refers to the raising of one (1) unit of swine in a pig pen in a household backyard;
- c. Farrowing is the process of growing pigs for breeding;
- d. Fattening refers to the process of growing pigs for slaughter;
- e. Inspection an act performed by a designated official to ensure compliance with the rules and regulations relevant to hygiene and sanitation, standard operating practices and hazard analysis and control;
- f. Nuisance anything that injures health, endangers life, offends the senses or produce discomfort to the community (Code on Sanitation PD 856);
- g. Practice the customary, habitual, or expected procedure or way of doing something:
- h. Radius a specified line or distance from a center in all directions;
- i. Standard Septic Tank a watertight, multi-chambered reservoir, the design and construction of which is based on a set standard, that receives/impounds sewage.

ARTICLE VI STANDARDS AND PRACTICES

Section 1. All backyard piggery projects must be registered in the barangay where they are located.

Section 2. The barangays are empowered to issue a permit to operate for each backyard project in their location provided this meets all the standards and regulatory requirements stated in this Ordinance and other pertinent laws, rules and regulations.

Section 3. Barangays are required to conduct an inventory of all backyard piggeries in their jurisdiction and submit this report to the city ENRO, copy furnished the Baybay City Backyard Piggery Task Force, the city health office and the city zoning board. The inventory report shall include the name of the owner of the backyard piggery, its location and other conditions under which the permit for its operation is granted, if there are any.

Section 4. Under this Ordinance, barangays are authorized to issue the permits and registration of the backyard piggeries under their jurisdiction and collect the corresponding fees. The fees to be collected shall be in accordance with the provisions of the Revenue Code of the city.

Section 5. Backyard piggeries shall not be nearer from each other within a 25-meter radius to mitigate nuisance, foul odor, fly infestation and water pollution. Should there be more than one backyard piggery within a 25-meter radius, these are required to form an association, and with financial and technical help from the city, shall be transferred to an appropriate location complete with the needed infrastructure for an efficient and environmentally sustainable operation.

Section 6. Each backyard piggery, whether for farrowing or fattening, shall contain only one (1) pig at any given time. In the case of farrowing, piglets shall be disposed no later than two (2) months after birth.

Section 7. The dimensions for each backyard pig pen are as follows:

- a. Farrowing four (4) meters square
- b. Fattening three (3) meters square

The bigger dimension for a farrowing backyard piggery is designed to accommodate the liter from the lactating sow. Pig pens shall be constructed out of concrete materials.

Section 8. Each backyard piggery is required to build a standard septic tank to impound sewage. The tank shall be watertight and shall not be constructed within a twenty-five (25) meter radius from any water source.

Section 9. Preferably, a piggery location must have good ventilation, proper drainage and shall not be near critical environmental areas such as a water source. It shall be unlawful to directly discharge animal waste into rice paddies an irrigation canal, rivers and other bodies of water.

ARTICLE VII BACKYARD PIGGERY TASK FORCE

Section 1. The Baybay City Backyard Piggery Task Force is created with the following composition:

Chairman - Head, City ENRO

Vice-Chair – SP Chairman, Committee on Environment

Members:

SP Chairman, Committee on Health and Sanitation

CHO

Zoning Board

Engineering Office

President, ABC

CAO

Representative from Hog growers

Section 2. This task force is mandated to oversee the implementation of the provisions of this Ordinance by the periodic monitoring and inspection of all backyard piggeries and conduct related activities as maybe required by laws, rules and regulations. It is further tasked to prepare a quarterly report and submit it to the Office of the Mayor of the results of its inspections and monitoring as well as its recommendations on how best to administer backyard pig raising in the city.

ARTICLE VIII PENAL CLAUSE

Section 1. The following fines shall be imposed on any violations of this Ordinance:

ARTICLE IX SEPARABILITY CLAUSE

Section 1. All provisions of this ordinance are hereby declared separable and if any provision shall be held invalid or unconstitutional, the remaining provisions hereof shall remain valid, in full force and effect.

ARTICLE X REPEALING CLAUSE

Section 1. All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this Ordinance, the same are hereby repealed, amended or modified accordingly...

ARTICLE XI **EFFECTIVITY CLAUSE**

Section 1. This ordinance shall take effect immediately upon its publication or after due compliance with all the requirements provided under RA 7160, otherwise known as the Local Government Code of 1991.
