RESOLUTION NO. 2022 – 112

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY OF BAYBAY WITH THE DEPARTMENT OF HEALTH-EASTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT (DOH-EVCHD) REPRESENTED BY DR. EXUPERIA B. SABALBERINO, MD, MPH, CESE, REGIONAL DIRECTOR AND THE WESTERN LEYTE PROVINCIAL HOSPITAL/IMMACULATE CONCEPTION HOSPITAL REPRESENTED BY DR. CHRISTINE N. BALDEVIA, CHIEF OF HOSPITAL, FOR THE IMPLEMENTATION OF MEDICAL ASSISTANCE TO INDIGENT PATIENT PROGRAM (MAIP) AMOUNTING TO TEN MILLION PESOS (PHP 10,000,000.00) OF THIS CITY.

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;

WHEREAS, pursuant to Republic Act No. 11518, otherwise known as the General Appropriations Act (GAA) for Fiscal Year 2022, SAA 22-01-0076 as Medical Assistance to Indigent Patients Fund allocated to DOH-EVCHD, intended as assistance to indigent patients;

WHEREAS, the City Government of Baybay concerned to the well-being of its constituents, entered into an agreement with the Department of Health-Eastern Visayas Center for Health Development (DOH-EVCHD) for the implementation of the Medical Assistance to Indigent Patient Program (MAIP);

WHEREAS, the august body finds the agreement essential and find the stipulations in order.

WHEREFORE, on motion of the SP Member Fulton lke C. Arradaza duly seconded by the SP Member Jorge V. Rebucas and Ex-Officio Member, Mark Michael O. Unlu-cay, be it;
