RESOLUTION NO. 2022 - 113

A RESOLUTION REQUESTING THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) THROUGH CHAIRMAN AND CEO ANDREA D. DOMINGO, FINANCIAL ASSISTANCE FOR THE CONSTRUCTION OF MULTI-PURPOSE EVACUATION CENTER (MPEC) WITH AN ESTIMATED PROJECT COST OF FIFTY MILLION PESOS (P50,000,000.00).

WHEREAS, Chapter II, Section 16 of the Local Government Code states: Every Local Government Unit shall exercise the powers expressly granted, those necessary implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance and those which are essential to the promotion of the general welfare;

WHEREAS, the City of Baybay, being the longest coastline in Region 8 has always been at risk to storm surge and flood, thereby endangering the lives of thousands of its residents during calamities and disasters;

WHEREAS, concerned with the well-being and highly committed to protect its people, the city government saw the need to establish appropriately designed and disaster resilient facility that will serve as temporary shelter during catastrophes, which entails adequate funding.

WHEREFORE, on motion of the SP Member Filemon F. Avila duly seconded by the SP Member Jorge V. Rebucas and Ex-Officio Member, Mark Michael O. Unlu-cay, be it;

RESOLVED, as it hereby does RESOLVE, to **REQUEST THE PHILIPPINE AMUSEMENT AND GAMING CORPORATION (PAGCOR) THROUGH CHAIRMAN AND CEO ANDREA D. DOMINGO, FINANCIAL ASSISTANCE FOR THE CONSTRUCTION OF MULTI-PURPOSE EVACUATION CENTER (MPEC) WITH AN ESTIMATED PROJECT COST OF FIFTY MILLION PESOS (P50,000,000.00).**
