RESOLUTION NO. 2022 - 120

SABALBERINO, MD, MPH, CESE, DIRECTOR IV AND ACCEPT THE DONATION OF ONE (1) UNIT DRESSING CART, AMOUNTING TO A TOTAL OF P16,500.00 INTENDED FOR BHS GUBANG, BAYBAY CITY.
