**RESOLUTION NO. 2022 – 121**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI, TO ENTER INTO A DEED OF DONATION WITH THE EASTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT (DOH-EV CHD), REPRESENTED BY EXUPERIA B. SABALBERINO, MD, MPH, CESE, DIRECTOR IV AND ACCEPT THE DONATION OF ONE (1) UNIT DRESSING CART, AMOUNTING TO A TOTAL OF P16,500.00 INTENDED FOR BHS KABUNGAAN, BAYBAY CITY.**


