BALDEVIA, M.D., CHIEF OF HOSPITAL, WESTERN LEYTE PROVINCIAL HOSPITAL/IMMACULATE CONCEPTION HOSPITAL FOR AN INCREASE OF PETTY CASH FOR THE OFFICE OF THE NUTRIONIST-DIETITIAN THROUGH MS. ALELI L. TURAN FROM FIFTY THOUSAND PESOS (P50,000.00) TO ONE HUNDRED THOUSAND PESOS (P100,000.00) TO CATER THE INCREASING NUMBER OF PATIENTS AT THE HOSPITAL, THIS CITY.
