**RESOLUTION NO. 2022 – 132**

**A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF MS. AMORLINA TABUDLONG BALAN, FOR TITLING AND POSSESSION OVER A PORTION OF PUBLIC LAND, CONTAINING AN AREA OF ONE HUNDRED SQUARE METERS (100 SQ.M.) LOCATED AT SAN JUAN LUNA ST., PUROK II OF BARANGAY SAN AGUSTIN OF THIS CITY.**

CARRIED UNANIMOUSLY.


