RESOLUTION NO. 2022 – 133

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY OF BAYBABY WITH THE DEPARTMENT OF HEALTH-EASTERN VISAYAS CENTER FOR HEALTH DEVELOPMENT (DOH-EVCHD) REPRESENTED BY EXUPERIA B. SABALBERINO, MD, MPH, CESE, REGIONAL DIRECTOR AND THE CITY HEALTH OFFICE REPRESENTED BY DR. NORBERTO OJA, CITY HEALTH OFFICER, FOR THE CONSTRUCTION OF SUPER HEALTH CENTER THRU THE HEALTH FACILITIES ENHANCEMENT PROGRAM (HFEP).

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;

WHEREAS, the City Government of Baybay entered into an agreement with the Department of Health-Eastern Visayas Center for Health Development (DOH-EVCHD) for the construction of Super Health Center thru the Health Facilities Enhancement Program (HFEP).

WHEREAS, the august body finds the agreement essential and find the stipulations in order.

WHEREFORE, on motion of the SP Member Fulton Ike C. Arradaza duly seconded by Ex-Officio Member, Mark Michael O. Unlu-cay, be it;
