

Minutes of the 10th Regular Session of the Sangguniang Panlungsod, conducted at the Legislative Session Hall, Legislative Building, Baybay City on March 10, 2022.

RESOLUTION NO. 2022 - 134

A RESOLUTION DECLARING THE SUPPLEMENTAL BUDGET FOR CY 2022 OF BARANGAY DON QUIRIMON ALKUINO-ZONE 11 IN THE AMOUNT OF TWENTY-THREE THOUSAND THREE HUNDRED TWENTY-ONE PESOS AND 87/100 (P23,321.87) TO BE IN CONFORMITY AND IN ACCORDANCE WITH THE EXISTING LAWS, RULES AND REGULATIONS OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM).

WHEREAS, Sub-section (a) of Section 333 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that: "Review of the Barangay Budget. - (a) within ten (10) days from its approval, copies of the barangay ordinance authorizing the annual appropriations shall be furnished to the Sangguniang Panlungsod or the Sangguniang Bayan, as the case may be, through the city or municipal budget officer;"

WHEREAS, same section further stresses that: "The Sanggunian concerned shall have the power to review such ordinance in order to ensure that the provisions of this Title are complied with;"

WHEREAS, the SP Committee on Finance, Budget & Appropriation of the City Government of Baybay has already reviewed the budget of Barangay Don Quirimon Alkuino-Zone 11 and found it to have complied with the budgetary requirements, set forth in R.A.7160.

WHEREFORE, on motion of the SP Member Edgardo R. Ompoy, duly seconded by Ex-Officio Member Mark Michael O. Unlu-cay, be it;

RESOLVED, as it hereby does RESOLVE, to DECLARE THE SUPPLEMENTAL BUDGET FOR CY 2022 OF BARANGAY DON QUIRIMON ALKUINO-ZONE 11 IN THE AMOUNT OF TWENTY-THREE THOUSAND THREE HUNDRED TWENTY-ONE PESOS AND 87/100 (P23,321.87) TO BE IN CONFORMITY AND IN ACCORDANCE WITH THE EXISTING LAWS, RULES AND REGULATIONS OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM).

RESOLVED FURTHER, that certified copies of this resolution be furnished to the Honorable Jose Carlos L. Cari, City Mayor, City Budget Office, City Accounting Office, City Treasurer's Office and other offices/agencies concerned for their information and guidance.
