RESOLUTION NO. 2022 – 136

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI, TO ENTER INTO A CONTRACT OF LEASE WITH SPS. EXPEDITO AND LOURDES JAVIER FOR THE USE BY THE CITY GOVERNMENT OF AN OFFICE SPACE SITUATED AT A. MABINI ST., BAYBAY CITY, PRESENTLY OCCUPIED BY THE DEPARTMENT OF AGRARIAN REFORM (DAR).

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;

WHEREAS, the SP Committee on Laws, Rules & Privileges was in receipt of a request for the renewal of a Contract of Lease of an office space occupied by the Department of Agrarian Reform (DAR);

WHEREAS, upon perusal of the documents submitted, found the same to be in order.


WHEREFORE, on motion of the SP Member Jose Rommel A. Peñaranda, duly seconded by all SP Members present, be it;



CARRIED UNANIMOUSLY.


