#### **RESOLUTION NO. 2022 - 138**

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI, TO DONATE A PORTION OF LOT NO. 1201-A, CONSISTING OF ONE THOUSAND THREE HUNDRED TWENTY-FIVE (1,325) SQ.M. AND LOT NO. 1198-A, CONSISTING OF ONE THOUSAND SIX HUNDRED SEVENTY-FIVE (1,675) SQ.M. OWNED BY THE CITY OF BAYBAY LOCATED AT BARANGAY GAAS, AS SITE FOR THE DEPED BAYBAY CITY DIVISION.

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;

WHEREAS, on August 17, 2015, the August body issued a Resolution No. 205 s. 2015, entitled "A Resolution authorizing the Honorable Carmen L. Cari, City mayor, to donate a portion of lot owned by the City of Baybay located at the Diversion Road, Brgy. Gaas for the site of the DepEd City Division Building with an area of Three Thousand Square Meters (3,000) square meters."

WHEREAS, the Donee, Department of Education, through the Baybay City Schools Division Office, requested for a supplemental Resolution relative to the said donation, defining the lot number of the parcel of land subject of the donation;

WHEREAS, the City Planning and Development Office (CPDO) presented before the council a sketch plan for the lot to be donated prepared by Engr. Aris Milloza, Geodetic Engineer signed by Engr. Patrick A. Postrero, City Planning and Development Officer, specifying the subject of the donation as Lot No. 1201-A consisting of 1, 325 square meters and Lot No. 1198-A consisting of 1,675 square meters.

WHEREFORE, on motion of the SP Member Edgardo R. Ompoy, duly seconded by all SP Members present, be it;

RESOLVED, as it hereby does RESOLVE, to AUTHORIZE THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI, TO DONATE A PORTION OF LOT NO. 1201-A, CONSISTING OF ONE THOUSAND THREE HUNDRED TWENTY-FIVE (1,325) SQ.M. AND LOT NO. 1198-A, CONSISTING OF ONE THOUSAND SIX HUNDRED SEVENTY-FIVE (1,675) SQ.M. OWNED BY THE CITY OF BAYBAY LOCATED AT BARANGAY GAAS, AS SITE FOR THE DEPED BAYBAY CITY DIVISION.

RESOLVED FURTHER, that certified copies of this resolution be furnished to the Honorable Jose Carlos L. Cari, City Mayor, Atty. Avito Cahig, Jr., City Legal Officer, Baybay City Division and other offices/agencies concerned for their information and appropriate action.
