Minutes of the 11th Regular Session of the Sangguniang Panlungsod, conducted at the Legislative Session Hall, Legislative Building, Baybay City on March 17, 2022.

RESOLUTION NO. 2022 – 139-1

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI, TO ENTER INTO AND SIGN A DEED OF CONDITIONAL DONATION OVER A PORTION OF LOT NO. 1200, CONSISTING OF TWO THOUSAND FIVE HUNDRED (2,500) SQUARE METERS, OWNED BY THE CITY OF BAYBAY LOCATED AT THE DIVERSION ROAD, BARANGAY GAAS, IN FAVOR OF THE PHILIPPINE NATIONAL POLICE (PNP), AS SITE FOR THE BAYBAY CITY POLICE STATION.

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;

WHEREAS, in 2014, a series of Resolution were issued by the August body relative to the intent of the city government to donate a parcel of land to the Philippine National Police, Baybay City as site for the Baybay City Police Station states, viz;

Resolution No. 054 s. 2014, dated March 3, 2014, confirming the donation of a portion of Lot No. 281 with an area of 600 square meters to be used as PNP Headquarters.

Resolution No. 243 s. 2014, authorizing the Honorable Carmen L. Cari, City Mayor to donate a portion of Lot No. 1195 with TCT NO. 11323 situated at Barangay Gaas this city to donate to the Philippine National police containing an area of 2,000 sq. meters as site of New Baybay City Police Station.

Resolution No. 310 s. 2014, authorizing Honorable Carmen L. Cari, City Mayor to donate a parcel of land owned by the City of Baybay located at Brgy. Gaas this city to the Philippine National Police with an area of Two Thousand Square Meters (2,000) sq. meters.

WHEREAS, the City Council upon perusal of the documents submitted by the PNP Baybay agreed to revoke all the aforementioned documents and issue a new one to conform with the existing site/location constructed of the Baybay City Police Station.

WHEREAS, the City Planning and Development Office (CPDO) presented before the council a sketch plan for the lot to be donated prepared by Engr. Aris Milloza, Geodetic Engineer, identifying a portion of Lot No. 1200 of the Baybay Cadastre located at the Diversion Road consisting of 2,500 square meters as the exact location/site of the Baybay City Police Station.

WHEREFORE, on motion of the SP Member Rodolfo S. Palma, Jr., duly seconded by all SP Members present, be it;

RESOLVED, as it hereby does RESOLVE, to AUTHORIZE THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI, TO ENTER INTO AND SIGN A DEED OF CONDITIONAL DONATION OVER A PORTION OF LOT NO. 1200, CONSISTING OF TWO THOUSAND FIVE HUNDRED (2,500) SQUARE METERS, OWNED BY THE CITY OF BAYBAY LOCATED AT THE DIVERSION ROAD, BARANGAY GAAS, IN FAVOR OF THE PHILIPPINE NATIONAL POLICE (PNP), AS SITE FOR THE BAYBAY CITY POLICE STATION.

RESOLVED FURTHER, that certified copies of this resolution be furnished to the Honorable Jose Carlos L. Cari, City Mayor, Atty. Avito Cahig, Jr., City Legal Officer, Baybay City Police Station and other offices/agencies concerned for their information and appropriate action.
