RESOLUTION NO. 2022 – 140

A RESOLUTION COMMENDING MS. ANTOINETTE CHERISH TAUS, FUNDING ORGANIZER AND COORDINATOR OF COMMUNITIES ORGANIZED FOR RESOURCE ALLOCATION (CORA), INCORPORATED FOR SPEARHEADING THE MANGROVE RESTORATION PROJECT IN THE COASTAL BARANGAYS OF SABANG, JAENA AND PUNTA, THIS CITY.

WHEREAS, over the years, mangroves, which makes significant contribution to coastal ecology, has been proven to protect coastlines by decreasing the risk of flooding and erosion, as well as supports livelihood and reduce social vulnerability by providing resources such as fish;

WHEREAS, there is a need to restore the degenerated mangroves along the coastline barangays of the city;
