RESOLUTION NO. 2022 – 144

JOSE ROMMEL A. PEÑARANDA (P168,000.00) & HON. JORGE V. REBUCAS (P100,000.00) IN THE TOTAL AMOUNT OF TWO HUNDRED SIXTY-EIGHT THOUSAND PESOS (P268,000.00) TO SPO PERSONAL SERVICES (OTHER PERSONNEL BENEFITS) MONETIZATION – TWO HUNDRED SIXTY-EIGHT THOUSAND PESOS (P268,000.00).

WHEREAS, upon perusal of the documents submitted, found the same to be in order and approved the said request.


WHEREFORE, on motion of the SP Member Edgardo R. Ompoy duly seconded by SP Member Filemon F. Avila, be it;


