RESOLUTION NO. 2022 – 147

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY OF BAYBAY WITH THE OFFICE OF THE PRESIDENT (OP) REPRESENTED BY THE EXECUTIVE SECRETARY, SALVADOR C. MEDIALDEA, FOR THE GRANT OF FIVE MILLION PESOS (P5,000,000.00) FINANCIAL AID, FOR THE COVID-19 RESPONSE-RELATED PROGRAMS OF BAYBAY CITY, LEYTE.

WHEREAS, on March 16, 2022, the Honorable City Mayor, Jose Carlos L. Cari wrote the Office of the President, His Excellency Rodrigo Roa Duterte, requesting Financial Aid for Covid-19 Response-Related Programs in the city.

WHEREAS, on March 24, 2022, a letter-reply from the Office of the President (OP) through the Office of the Deputy Executive Secretary for Finance and Administration was received by the city, requiring among others an SP Resolution authorizing the Local Chief Executive to enter into MOA with the Office of the President, relative to the requested financial assistance.


WHEREFORE, on motion of the SP Member, Fulton Ike C. Arradaza duly seconded by All SP Members present, be it;
