WHEREAS, Section 22 of the Local Government Code of the Philippines provides that every local government unit, as a corporation, shall have the following powers;

1. To have continuous succession in its corporate name;
2. To sue and be sued;
3. To have and use a corporate seal;
4. **To acquire and convey real or personal property;**
5. **To enter into contracts; and**
6. To exercise such other powers as are granted to corporations, subject to the limitations provided in this Code and other laws.

WHEREAS, Section 22 (c) of the same code further mandates that unless otherwise provided by this code, no contract may be provided by the local chief executive in behalf of the Local Government Unit without prior authorization by the sanggunian concerned;

WHEREAS, said donation aims to improve the livelihood project of the association through the upgrading of its facilities to make them more responsive to the demand of the general public;

WHEREAS, the august body find the stipulations of the deed of donation in order.

WHEREFORE, on motion of the SP Member, Jose Rommel A. Peñaranda duly seconded by All SP Members present, be it;




