RESOLUTION NO. 2022 - 149

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR JOSE CARLOS L. CARI, TO ENTER INTO A CONTRACT OF SERVICE WITH DR. VICTORIA NATASSA M. LEOMO, AS MEDICAL SERVICE PROVIDER, TASKED TO PROVIDE MEDICAL SERVICES AT THE WESTERN LEYTE PROVINCIAL HOSPITAL / IMMACULATE CONCEPTION HOSPITAL, FOR THE PERIOD COVERING FROM JANUARY 3, 2022 TO JUNE 30, 2022 WITH A MONTHLY CONTRACT FEE OF FORTY-FIVE THOUSAND PESOS (P45,000.00) PESOS.

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance.

WHEREAS, the City Government concerned with the health and welfare of its constituents aims to improve services provided by the Western Leyte Provincial Hospital / Immaculate Conception Hospital by hiring additional medical practitioners who possess knowledge, skills and experience in the field of anaesthesiology:

WHEREAS, the expertise of Dr. Victoria Natassa M. Leomo is essential to deliver the needed medical services at the Western Leyte Provincial Hospital/Immaculate Conception Hospital;

WHEREFORE, on motion of the SP Member Edgardo R. Ompoy duly seconded by Ex-Officio Member, Mark Michael O. Unlu-cay, be it;

RESOLVED, as it hereby does RESOLVE, to AUTHORIZE THE HONORABLE CITY MAYOR JOSE CARLOS L. CARI, TO ENTER INTO A CONTRACT OF SERVICE WITH DR. VICTORIA NATASSA M.
