**RESOLUTION NO. 2022 – 154**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR JOSE CARLOS L. CARI, TO ENTER INTO A CONTRACT OF SERVICE WITH DR. RUTH ABUYABOR OMEGA, AS MEDICAL SERVICE PROVIDER, TASKED TO PROVIDE MEDICAL SERVICES AT THE BAYBAY CITY MEDICAL DIAGNOSTIC AND DIALYSIS CENTER (BCMDDC), FOR THE PERIOD COVERING FROM JANUARY 3, 2022 TO JUNE 30, 2022 WITH A MONTHLY CONTRACT FEE OF EIGHTY THOUSAND FIVE HUNDRED PESOS (P80,500.00).**

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance.

WHEREAS, the City Government concerned with the health and welfare of its constituents aims to improve services provided by the Baybay City Medical Diagnostic and Dialysis Center (BCMDDC) by hiring additional medical practitioners who possess knowledge, skills and experience in the field of radiology;

WHEREAS, the expertise of Dr. Ruth Abuyabor Omega is essential to deliver the needed medical services at the Baybay City Medical Diagnostic and Dialysis Center (BCMDDC);


WHEREFORE, on motion of the SP Member Jorge V. Rebucas duly seconded by SP Member, Filemon F. Avila, be it;


