**RESOLUTION NO. 2022 - 159**

**A RESOLUTION DECLARING THE ENTIRE CITY OF BAYBAY UNDER THE STATE OF CALAMITY DUE TO TYPHOON "AGATON"**

WHEREAS, Article 99 (IV) of LGC of 1991, Implementing Rules & Regulation provides that: the Sangguniang Panlungsod, as legislative body of the city shall approve ordinances and pass resolutions necessary for an efficient and effective city government, and relative thereto, shall adopt measures to protect the inhabitants of the city from the harmful effects of man-made or natural disasters and calamities, and to provide relief services and assistance for victims during and the aftermath of said disaster or calamities and this return to productive livelihood following said events.

WHEREAS, on April 10, 2022 the City of Baybay, was among those hit by Typhoon Agaton which brought torrential rains for several days non-stop, resulting to fatalities and injuries, massive destruction of houses and infrastructures due to heavy flooding and landslides in various barangays, vegetable production destroyed while coconut farms, corn lands, livestock production are heavily damaged.

WHEREAS, per initial report from the City Disaster Risk Reduction Management Office (CDRRMO), there is an urgent need to extend immediate basic services and financial support to the affected inhabitants in order that normalcy is achieved the soonest possible opportunity, enabling residents to continue to their day to day lives;

WHEREAS, the affected Baybayanons if not given immediate food relief, financial assistance, and care by the city government, including health, sanitation and means of livelihood, are in great jeopardy;

WHEREAS, the declaration of state of calamity will hasten the relief and rehabilitation efforts of the government;

WHEREFORE, on Mass motion of all the SP Members present, be it;

RESOLVED, as it hereby does RESOLVE, to **DECLARE THE ENTIRE CITY OF BAYBAY UNDER THE STATE OF CALAMITY DUE TO TYPHOON "AGATON"**



CARRIED UNANIMOUSLY.


