RESOLUTION NO. 2022 - 160

A RESOLUTION REQUESTING THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGION 8 THROUGH OIC, REGIONAL EXECUTIVE DIRECTOR, ARTURO E. FADRIQUELA TO ALLOW LGU-BAYBAY TO CONDUCT SALVAGE OPERATION ON ALL FALLEN TREES DUE TO TYPHOON AGATON IN THE ENTIRE CITY.

WHEREAS, on April 10, 2022 the City of Baybay, was among those hit by Typhoon Agaton which brought torrential rains for several days non-stop, resulting to fatalities and injuries, massive destruction of houses and infrastructures due to heavy flooding and landslides in various barangays, vegetable production destroyed while coconut farms, corn lands, livestock production are heavily damaged.

WHEREAS, there is a need to conduct salvage operation on all fallen trees in the entire territorial jurisdiction of the city, in order to expedite the road clearing operations made due to typhoon Agaton and to use the lumber for repair and rehabilitation of damaged houses and facilities.

WHEREFORE, on motion of the SP Member Filemon F. Avila, duly seconded by the all SP Members present, be it;

RESOLVED, as it hereby does RESOLVE, to REQUEST THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGION 8 THROUGH OIC, REGIONAL EXECUTIVE DIRECTOR, ARTURO E. FADRIQUELA TO ALLOW LGU-BAYBAY TO CONDUCT SALVAGE OPERATION ON ALL FALLEN TREES DUE TO TYPHOON AGATON IN THE ENTIRE TERRITORIAL JURISDICTION OF THE CITY.

RESOLVED FURTHER, that certified copies of this resolution be furnished to the Honorable Jose Carlos L. Cari, City Mayor, Arturo E. Fadriquela, OIC, Regional Executive Director, Department of Environment and Natural Resources (DENR) and other offices/agencies concerned for their information and appropriate action.
