RESOLUTION NO. 2022 - 162

A RESOLUTION TEMPORARILY CLOSING THE BARANGAY ROAD OF BARANGAY BUBON FROM NON-RESIDENTS OF THE SAID BARANGAY.

WHEREAS, on April 10, 2022 the City of Baybay, was among those hit by Typhoon Agaton which brought torrential rains for several days non-stop, resulting to fatalities and injuries, massive destruction of houses and infrastructures due to heavy flooding and landslides in various barangays.

WHEREAS, it has been observed recently that a surge of onlookers with vehicles flocking to Brgy. Bubon just to see and take pictures of the mountain landslide in Brgy. Kantagnos thereby causing heavy traffic in Brgy. Bubon.

WHEREAS, the city agreed the temporary closure of the barangay road of Barangay Bubon from non-residents in order not to hamper the on-going search, rescue and retrieval operations conducted by the City Government of Baybay and authorize the Tanods of Brgy. Bubon to assist in vehicle and traffic management in the area.

WHEREFORE, on motion of the SP Member Jorge V. Rebucas duly seconded by the Ex-Officio Member Mark Michael O. Unlu-cay, be it;

RESOLVED, as it hereby does RESOLVE, to TEMPORARILY CLOSE THE BARANGAY ROAD OF BARANGAY BUBON FROM NON-RESIDENTS OF THE SAID BARANGAY.

RESOLVED FURTHER, that certified copies of this resolution be furnished to the Honorable Jose Carlos L. Cari, City Mayor, City Engineering Office, Barangay Captain Mildred O. Subong and other offices/agencies concerned for their information and appropriate action.
