RESOLUTION NO. 2022 - 163

A RESOLUTION INDORSING TO THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI THE HEREIN RESOLUTION NO. 022 S. OF 2022 OF BARANGAY CARIDAD, "REQUESTING TECHNICAL AND LEGAL ASSISTANCE FROM LGU-BAYBAY CITY TO APPLY A PORTION OF THE ABANDONED OLD PROVINCIAL ROAD ALSO KNOWN AS "SPANISH ROAD" WITH THE DENR-CENRO, BAYBAY CITY, AS RELOCATION SITE FOR RESIDENTS WHOSE HOUSES ARE PRESENTLY ERECTED ON AREAS IDENTIFIED AS "DANGER ZONES"

WHEREAS, the Sangguniang Panlungsod is in receipt of Resolution N. 022 from the Barangay Council of Caridad;

WHEREAS, said resolution sought for technical and legal assistance from the city government in their intent to use a portion of the abandoned provincial road located in the said barangay as relocation site for residents presently dwelling in identified Danger Zones;

WHEREAS, the honorable council found merit on the resolution thereby indorsing the same to the Local Chief Executive.


