RESOLUTION NO. 2022 - 164

A RESOLUTION REQUESTING THE NATIONAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (NDRRMC) THRU THE OFFICE OF THE CIVIL DEFENSE (OCD), USEC RICARDO B. JALAD, EXECUTIVE DIRECTOR, FINANCIAL ASSISTANCE FOR THE REHABILITATION/RESTORATION OF THE WATER SYSTEM OF BAYBAY CITY, LEYTE IN THE AMOUNT OF THIRTY MILLION PESOS (P30,000,000.00) PER ATTACHED PROGRAM OF WORK

WHEREAS, the City of Baybay had been worst-hit by Typhoon Agaton which caused massive damage to the city's water system;

WHEREAS, it is the desire of the city government to provide potable water to the Baybayanons, hence this request to the National Disaster Risk Reduction and Management Council (NDRRMC) for financial assistance in order to rehabilitate and restore the pipelines connecting the water sources to the poblacion or city proper concessionaires.
