**RESOLUTION NO. 2022 - 166**

**A RESOLUTION REQUESTING THE PROVINCIAL GOVERNMENT OF LEYTE THRU GOVERNOR LEOPOLDO DOMINICO L. PETILLA, FINANCIAL ASSISTANCE TO AUGMENT THE MAINTENANCE AND OTHER OPERATING EXPENSES OF THE NEW WESTERN LEYTE PROVINCIAL HOSPITAL/IMMACULATE CONCEPTION HOSPITAL LOCATED AT DIVERSION ROAD, BRGY. COGON, THIS CITY**
