**RESOLUTION NO. 2022 - 33**

A RESOLUTION DECLARING THE ANNUAL BUDGET FOR CY 2022 OF **BARANGAY BARTOLOME BARTOLINI-ZONE 20** IN THE AMOUNT OF **TWO MILLION FIVE HUNDRED SIXTY-SEVEN THOUSAND THREE HUNDRED TWENTY-EIGHT PESOS (P2,567,328.00)** TO BE IN CONFORMITY AND IN ACCORDANCE WITH THE EXISTING LAWS, RULES AND REGULATIONS OF THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM).

WHEREAS, Sub-section (a) of Section 333 of R.A. 7160, otherwise known as the Local Government Code of 1991, provides that: "Review of the Barangay Budget. – (a) within ten (10) days from its approval, copies of the barangay ordinance authorizing the annual appropriations shall be furnished to the Sangguniang Panlungsod or the Sangguniang Bayan, as the case may be, through the city or municipal budget officer;"

WHEREAS, same section further stresses that: "The Sanggunian concerned shall have the power to review such ordinance in order to ensure that the provisions of this Title are complied with;"

WHEREAS, the SP Committee on Finance, Budget & Appropriation of the City Government of Baybay has already reviewed the budget of Barangay Bartolome Bartolini-Zone 20 and found it to have complied with the budgetary requirements, set forth in R.A.7160.




