**RESOLUTION NO. 2022 - 45**

**A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH MS. ANTONETTE TAUS, EXECUTIVE DIRECTOR OF THE COMMUNITIES ORGANIZED FOR RESOURCE ALLOCATION (CORA), FOR THE IMPLEMENTATION OF THE "WOMANGROVE WARRIORS" IN THE COASTAL BARANGAYS OF SABANG, JAENA, AND PUNTA, THIS CITY.**

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance.

WHEREAS, the City Government of Baybay, concerned with the conservation and restoration of the degraded mangroves entered into an agreement with the Communities Organized for Resource Allocation (CORA), Inc.

WHEREAS, the august body finds the agreement essential and find the stipulations of the agreement in order.




