**RESOLUTION NO. 2022 - 46**

**A RESOLUTION REQUESTING THE PHILIPPINE COCONUT AUTHORITY (PCA) THROUGH ADMINISTRATOR, GENERAL BENJAMIN R. MADRIGAL JR., FOR THE ALLOCATION OF EIGHTY THOUSAND (80,000) HYBRID COCONUT SEEDLINGS TO REPLACE THE MORE THAN SIXTY THOUSAND (60,000) TOTALLY DAMAGED COCONUT TREES IN THE CITY OF BAYBAY DUE TO TYPHOON ODETTE.**

WHEREAS, Typhoon Odette that hit the city on December 16, 2021, severely damaged the coconut industry in the area;

WHEREAS, there is an immediate need to address the pressing concern of restoration/rehabilitation of the said industry which is one of the major source of income of the Baybayanons;

WHEREAS, the said restoration/rehabilitation entails a supply of coconut seedlings to replace thousands of damaged coconut trees.


WHEREFORE, on motion of the SP Member, Ramon Ronald J. Veloso duly seconded by SP Member Filemon F. Avila, be it;

**RESOLVED, as it hereby does RESOLVE, to REQUEST THE PHILIPPINE COCONUT AUTHORITY (PCA) THROUGH ADMINISTRATOR, GENERAL BENJAMIN R. MADRIGAL JR., FOR THE ALLOCATION OF EIGHTY THOUSAND (80,000) HYBRID COCONUT SEEDLINGS TO REPLACE THE MORE THAN SIXTY THOUSAND (60,000) TOTALLY DAMAGED COCONUT TREES IN THE CITY OF BAYBAY DUE TO TYPHOON ODETTE.**


