RESOLUTION NO. 2022 - 55

A RESOLUTION ADOPTING THE HEREIN RESOLUTION NO. 3, S. 2022 OF THE CITY DEVELOPMENT COUNCIL (CDC), "APPROVING THE RE-ALIGNMENT OF THE BARANGAY PROJECT OF BARANGAY BALAO IN THE TOTAL AMOUNT OF EIGHT HUNDRED THOUSAND (P800,000.00) PESOS FROM THE BUDGET FOR THE CONSTRUCTION OF KINDERGARTEN BUILDING, AMOUNTING TO FOUR HUNDRED FIFTY THOUSAND (P450,000.00) PESOS AND CONSTRUCTION OF COMFORT ROOM AMOUNTING TO THREE HUNDRED FIFTY THOUSAND (P350,000.00) PESOS.

WHEREAS, upon perusal and review of the documents submitted, found the same to be in order.






