RESOLUTION NO. 2022 - 56

A RESOLUTION INTERPOSING NO OBJECTION TO THE REQUEST OF MR. ARNEL D. LIM OF BRGY. MAYPATAG, BAYBAY CITY, FOR A GRATUITOUS PERMIT BEFORE THE PROPER GOVERNMENT AGENCIES TO EXTRACT SAND AND GRAVEL ON A PORTION OF THE RIVER ADJACENT TO HIS PROPERTY LOCATED AT BARANGAY MAYPATAG, THIS CITY.

WHEREAS, the Committee on Environment, Natural Resources & Conservation was in receipt of a letter-request for a gratuitous permit before the proper government agencies to extract Sand and Gravel on a portion of the river adjacent to his property located at Barangay Maypatag as a requirement for the issuance of permit from the Office of the City Environment and Natural Resources Office (CITY ENRO);

WHEREAS, attached to the said request is a Resolution interposing no objection issued by the Barangay Council of Maypatag dated December 10, 2021 where the said extraction will be conducted.


