RESOLUTION NO. 2022 - 58

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE RED CROSS-ORMOC CHAPTER, REPRESENTED BY MS. ELIZABETH S. SAVALLA, SECRETARY GENERAL, TO ADDRESS THE PRESENT SHORTAGE OF BLOOD SUPPLY IN THE PRC-ORMOC CITY CHAPTER.

WHEREAS, Section 455 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that local chief executives shall represent the city in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Panlungsod or pursuant to law or Ordinance;

WHEREAS, there is an alarming increase in the number of medical and surgical cases from Ormoc City and its neighboring towns and most, if not all of these cases require blood transfusion;

WHEREAS, the City Government of Baybay concerned to the well-being of its constituents and that of the neighboring localities, entered into an agreement with the Philippine Red Cross-Ormoc Chapter to address the present shortage of blood supply in the PRC-Ormoc Chapter;

WHEREAS, the august body finds the agreement essential and find the stipulations of the agreement in order.


