**RESOLUTION NO. 2022 – 74**

**A RESOLUTION INTERPOSING NO OBJECTION TO THE APPLICATION OF MR. CHITO TABUDLONG BALAN, FOR TITLING AND POSESSION OVER A PORTION OF PUBLIC LAND, CONTAINING AN AREA OF ONE HUNDRED SQUARE METERS (100 SQ.M.) LOCATED AT SAN JUAN LUNA ST., PUROK II OF BARANGAY SAN AGUSTIN OF THIS CITY.**

WHEREAS, presented for consideration was the request of Mr. Chito Tabudlong Balan, a resident of Barangay San Agustin for a resolution interposing no objection to his application for titling and possession over a portion of public land containing an area of 100 square meters located at San Juan Luna St., Purok II of said barangay;
