RESOLUTION NO. 2022 – 75

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI FOR THE UTILIZATION OF THE 2019 DISASTER RISK REDUCTION MANAGEMENT (DRRM) TRUST FUND IN THE AMOUNT OF EIGHTEEN MILLION FOUR HUNDRED FIFTY-FIVE THOUSAND TWO HUNDRED THIRTY-NINE PESOS AND 03/100 (P18,455,239.03), TO ADDRESS THE PRESSING CONCERNS ON DISASTER PREPAREDNESS, RECOVERY AND REHABILITATION OF THE AGRICULTURE SECTOR WHICH WAS SEVERELY AFFECTED BY TYPHOON ODETTE THAT HIT THE CITY LAST DECEMBER 16, 2021.

WHEREAS, presented for consideration was the joint Resolution No. 2022-01 of the City Inter-Agency Task Force COVID-19 and City Disaster Risk Reduction Management Council;

WHEREAS, upon perusal of the documents submitted, the August body found the same to be in order;


WHEREFORE, on motion of the SP Member Edgardo R. Ompoy duly seconded by the SP Members present, be it;
