**RESOLUTION NO. 2022 – 87**

**A RESOLUTION CONCURRING AND ADOPTING RESOLUTION NO. 3, S. 2022 OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL, APPROPRIATING FOUR MILLION PESOS (P4,000,000.00) FROM THE UNSPENT TRUST FUND OF 2020 TO EXTEND CASH ASSISTANCE TO THE ELIGIBLE TRANSPORT DRIVERS OF THE CITY IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) EACH.**

WHEREAS, upon perusal of the documents submitted, the August body found the same to be in order;




