## RESOLUTION NO. 2022 - 88

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, JOSE CARLOS L. CARI, TO ALLOCATE AND DISBURSE FUNDS AS CASH ASSISTANCE TO THE ELIGIBLE TRANSPORT DRIVERS AFFECTED BY TYPHOON ODETTE AND THE STRICT PROTOCOL OF COVID-19 PLACING BAYBAY CITY UNDER ALERT LEVEL 3 IN THE AMOUNT OF TWO THOUSAND PESOS (P2,000.00) EACH.
