RESOLUTION NO. 2022 – 92

WHEREAS, this august body finds the request essential, thus endorses for its approval.


WHEREFORE, on motion of the SP Member, Jorge V. Rebuscas duly seconded by SP Member, Filemon F. Avila, be it;



CARRIED UNANIMOUSLY.


