RESOLUTION NO. 2022 – 98

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR JOSE CARLOS L. CARI, TO ENTER INTO A CONTRACT OF SERVICE WITH MS. APRIL ATHENA D. CABALONA, A RESIDENT OF BRGY. 84, SAN JOSE, TACLOBAN CITY, LEYTE TO ASSIST THE CITY GOVERNMENT OF BAYBAY IN DRAFTING THE UPDATED MANUAL OF HOSPITAL POLICIES AND PROCEDURES, FOR THE PERIOD COVERING FROM JANUARY 1, 2022 TO JUNE 30, 2022 WITH A MONTHLY CONTRACT FEE OF FIFTEEN THOUSAND (P15,000.00) PESOS.




