## RESOLUTION NO. 2022 - 99

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR JOSE CARLOS L. CARI, TO ENTER INTO A CONTRACT OF AFFILIATION WITH THE VISAYAS STATE UNIVERSITY, REPRESENTED BY THE PRESIDENT, DR. EDGARDO E. TULIN, FOR THE PROVISION OF BASIC CLINICAL SERVICES FOR THE STUDENTS' EDUCATION IN NURSING, FOR THE PERIOD OF TWO (2) YEARS AT THE WESTERN LEYTE PROVINCIAL HOSPITAL/IMMACULATE CONCEPTION HOSPITAL (WLPH/ICH) OF THIS CITY.

WHEREAS, the SP Committee on Health and Sanitation is in receipt of a Contract of Affiliation from the Visayas State University (VSU);

WHEREAS, the august body finds the agreement essential to provide the students opportunity to apply their knowledge on basic clinical services, thus endorses said contract.
